The undersigned Subscriber hereby makes, subscribes, acknowledges, and files with the Secretary of State of the State of Florida these Articles of Incorporation, for the purpose of forming a corporation for profit, in accordance with Chapter 607, Florida Statutes, Florida Business Corporation Act.

ARTICLE I - NAME

The name of this corporation is EVERGREEN CAPITAL MANAGEMENT, INC., and the principal place of business and mailing address of this corporation shall be 17315 Linda Vista Circle, Lutz, Florida 33549.

ARTICLE II - NATURE OF BUSINESS

This corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

ARTICLE III - REGISTERED OFFICE AND REGISTERED AGENT

The address of the initial registered office of this corporation in the State of Florida is 17315 Linda Vista Circle, Lutz, Florida 33549; and the initial registered agent is RONALD E. KIBBE. The Board of Directors may, from time to time, move the
