The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The name of the corporation is ACC - Acquisition Subsidiary, Inc. (the "Corporation").

THIRD: The Corporation shall have authority to issue not more than 1,000 shares of common stock of \$0.01 par value per share.

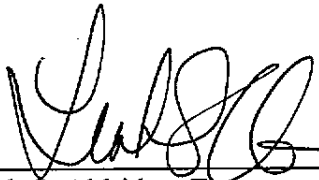
