



ARTICLES OF INCORPORATION OF LOUIS & MARY HUNTLEY, INC.



The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopt the following Articles of Incorporation:

ARTICLE I

<u>Name</u>

The name of the corporation is Louis & Mary Huntley, Inc.

ARTICLE II

Principal Office

The principal office and mailing address of the corporation shall be 401 Milwaukee Avenue, Orange Park, Florida 32073.
