ARTICLES OF INCORPORATION

OF

AZTEC HOLDINGS, INC.

ARTICLE I - NAME

The name of this Corporation is AZTEC HOLDINGS, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on October 15 1998.

ARTICLE III - PURPOSE
