The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I

NAME

The name of the corporation shall be SEBASTIAN ISLAND, INC.

The corporation shall be deemed to commence its existence on the date of filing. The term of existence of the corporation is perpetual.
