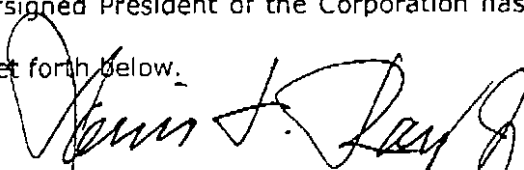

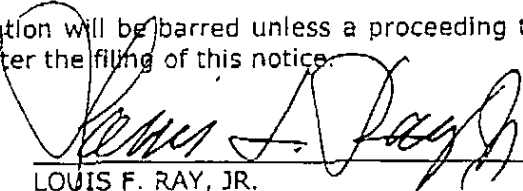
**NOTICE OF DISSOLUTION

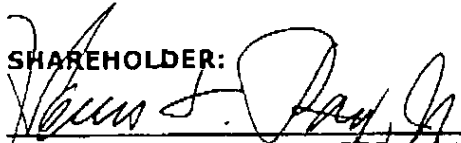
