# ARTICLES OF INCORPORATION

ARTICLE I -- NAME

# ARTICLE IV-- CAPITAL STOCK


This corporation is authorized to issue 7500 shares of One Dollar (1.00) par value common stock which shall be designated as "Common Shares".
