The undersigned, acting as incorporator of **DISTRACED RECORDS, INC.** under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of the corporation is **DISTRACED RECORDS, INC.**

**ARTICLE II. ADDRESS**

The mailing address of the corporation is 555 Jefferson Avenue, Miami Beach, Florida 33139.

**ARTICLE III. COMMENCEMENT OF EXISTENCE**

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

**ARTICLE IV. PURPOSE**

The corporation is organized to engage in any activity or business permitted under the laws of the United States and Florida.

**ARTICLE V. AUTHORIZED SHARES**

The maximum number of shares that the corporation is authorized to have outstanding at any time is 10,000 shares of common stock having a par value of \$.01 per share.

#### **ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT**

#### **ARTICLE VII. INCORPORATOR**

The name and street address of the incorporator are Jorge L. Hernandez-Torano, 701 Brickell Avenue, Suite 3000, Miami, Florida 33131.


#### **ARTICLE VIII. BYLAWS**
