**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

FIRST: The name of the Corporation is DISTRACTED RECORDS, INC.


SECOND: Article I. of the Articles of Incorporation of the Corporation is amended in its entirety as follows:
