Pursuant to the provisions of Section 607.0501 or 617.0501 . Florida Statutes, this corporation adopts the following Articles of Incorporation.

Article I. - Name and Principal Office

The name of the corporation shall be DHARMAR COMMUNICATIONS, INC., and the principal office shall be 4510 OAK FAIR BOULAVARD, SUITE 202, TAMPA, FLORIDA 33619. The type of corporation: Close.

Article II. - Purpose

This corporation may engage or transact in any or all lawfull activities or business permitted under the laws of the United States, the State of Florida of any other state, country, territory or nation.

Article III. - CAPITAL STOCK

The amount of capital stock authorized shall consist of 100 shares of common voting stock having no par value per share. The capital stock of the corporation may at any time be increased or decreased as provided by the laws of Florida.

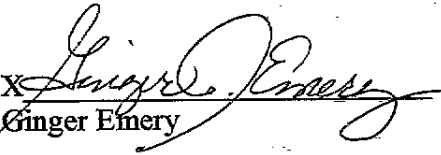
