ARTICLES OF INCORPORATION OF

ARTICLE I

THE NAME OF THE CORPORATION SHALL BE: MOSOR INC.

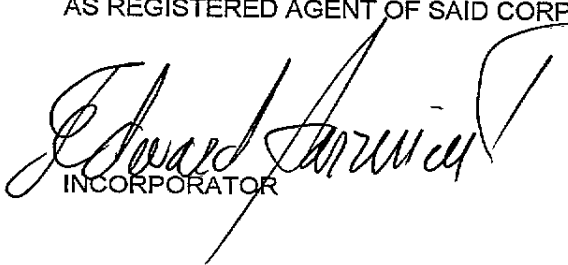
ARTICLE VII
