ARTICLES OF INCORPORATION

ARTICLE I

CORPORATE NAME

The name of the Corporation is:

ARTICLE II

PURPOSE

The purpose of the Corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporate Act, Chapter 607 of the State of Florida other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the State of Florida Corporations Code.
