ARTICLES OF INCORPORATION

Article I - Name

CORPORATEON ETANY OF STATE The name of this corporation is LP AUTO TALLAHASSEE, FLORIDA

Article II -Purpose

This corporation is organized to establish a quality auto dealership, and for all other lawful businesses.

Article III - Capital Stock

This corporation is authorized to issue Ten Thousand (19,000) shares of One and No/100(\$1.00) Dollar par value common stock.
