The undersigned incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I: NAME**

The name of the Corporation shall be: NCA INTERNATIONAL OCEAN FREIGHT FORWARDERS, INC.

**ARTICLE II: PRINCIPAL OFFICE**

The principal office of the Corporation shall be located at 1803 N. 22<sup>nd</sup> St., Tampa, FL. 33605 but the Corporation shall have power to establish branch offices and other places of business at such other places within or without the State of Florida, as may be determined and deemed expedient by the Directors.

**ARTICLE III: CAPITAL STOCK**
