Dear sirs:

Apparently due to a typographical error in your database, our corporate mailing address has been recorded incorrectly for approximately two years. Consequently, we did not receive necessary forms to file Annual Reports in 1999 or 2000. It has just now come to our attention that the corporation was administratively dissolved due to this oversight.

Prior to becoming a Florida corporation, we had been registered as a foreign corporation for eight years. According to your online database (see enclosed printouts), our mailing address was recorded correctly on our foreign corporation withdrawal, but was recorded incorrectly on our Florida incorporation, both events occurring October 23, 1998.

As a foreign corporation, we had consistently filed Annual Reports in a timely manner since 1990. Under the circumstances, we trust that you will accept the enclosed 1999 and 2000 filing fees, totaling \$300, for reinstatement of our Florida corporation to active status.
