ARTICLES OF AMENDMENT TO THE AMENDED AND RESTATED ARTICLES OF INCORPORATION OF TRIVEST-DYNO CO. a Florida corporation

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, TRIVEST-DYNO CO., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Amended and Restated Articles of Incorporation:

FIRST. The date of filing the Amended and Restated Articles of Incorporation was October, 1998 (Document No. P98000090959).

SECOND. The following amendment to the Amended and Restated Articles of Incorporation was adopted by the Corporation:

A. Article I of the Amended and Restated Articles of Incorporation of the Corporation is hereby amended as follows:

ARTICLE I Name

The new name of the Corporation is TRIVEST-POMPANO CO.

THIRD. Except as hereby amended, the Amended and Restated Articles of Incorporation of the Corporation shall remain unchanged.

In accordance with Section 607.0123(1)(b) of the Florida Business Corporation Act, this Amendment shall be effective as of July 21, 2005.

The foregoing Amendment to the Amended and Restated Articles of Incorporation of the Corporation was proposed and unanimously approved by the Corporation's Directors and a majority of the Shareholders by Joint Written Consent effective as of July 21, 2005 pursuant to Sections 607.0704 and 607.0821 of the Florida Business Corporation Act.
