# ARTICLES OF INCORPORATION OF FIXEL MANUFACTURING INDUSTRIES, INCECRETARY OF STATE TALLAHASSEE, FLORIDA

### ARTICLE I - Name

The name of the corporation is FIXEL MANUFACTURING INDUSTRIES, INC. (the "Corporation").
