ARTICLES OF INCORPORTATION OF L KAY RECORDS, INCORPORATED

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE I - NAME

The name of this corporation shall be L KAY RECORDS, INCORPORATED.

ARTICLE II - NATURE OF BUSINESS

The specific purpose of this corporation is to engage in all aspects of the music industry, including but not limited to: the production and creation of musical recordings, tapes, compact discs, musical literature, and the manufacture and sale of records and all related products. 
