ARTICLE I
NAME

The name of this corporation is:

PLUMBERS WHOLESale, INC.

ARTICLE II
PURPOSE

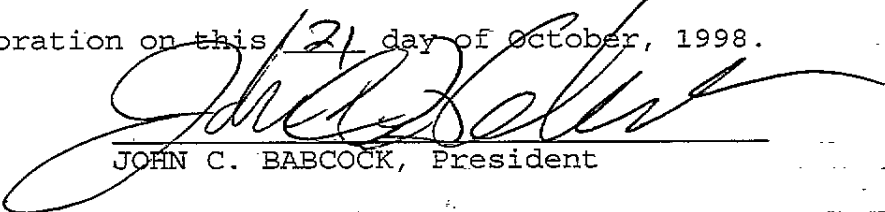

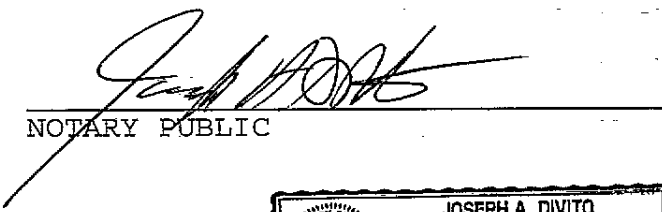
