ARTICLES OF INCORPORATION

of

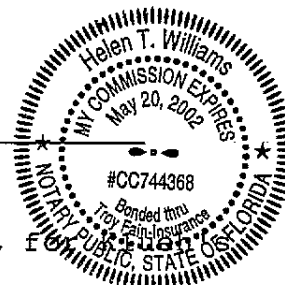
