ARTICLE EIGHT - LIMITATION OF LIABILITY

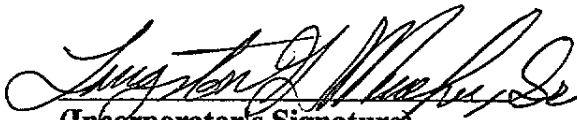
