## ARTICLES OF AMENDMENT

SECRETARY OF STAIL TALLAHASSEE, FLORIDA

Pursuant to Section 607.1006 of the Florida Business Corporation Act, MAIN STREET WHOLESALE CORPORATION, a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation, which were originally filed with the Secretary of State of the State of Florida on October 26, 1998:

1. The name of the Corporation is:

#### MAIN STREET WHOLESALE CORPORATION

2. The following Amendment to the Articles of Incorporation were recommended by the Board of Directors and approved by the Shareholders of the Corporation, in the manner prescribed by the Florida Business Corporation Act, and in accordance with its Articles of Incorporation and Bylaws, on June 1, 1999. The first sentence of Article 1 of the Articles of Incorporation is amended to read as follows:

### "Article 1 - Name
