**ARTICLE IX**



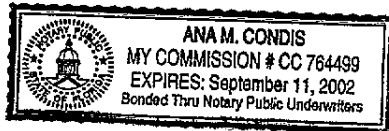
