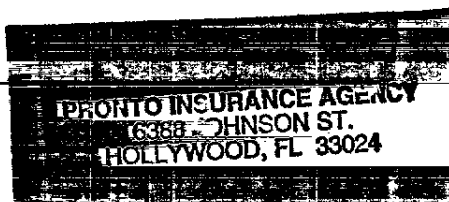

CERTIFICATE OF INCORPORATION

OF

THE UNDERSIGNERS SUBSCRIBERS of these ARTICLES OF INCORPORATIONS each a natural person, competent to contract, hereby associate themselves together to form a Corporation for Profit, under the Laws of the State of Florida; and further do agree to the following conditions of said Corporation.

ARTICLE I : NAME

The name of the Corporation is :

ARTICLE II : NATURE OF BUSINESS

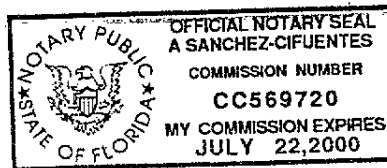

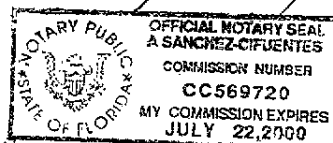

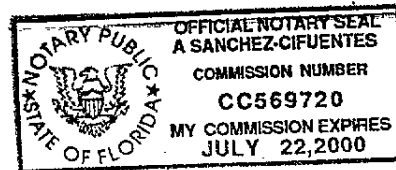
