The undersigned incorporator, for the purpose of forming a professional association under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I: The name of the professional association is TIMOTHY E. FEE, M.D., P.A.

ARTICLE II: The corporation shall exist for perpetuity commencing on the first day of January, 1999.

EFFECTIVE DATE

ARTICLE III: This professional association is organized for any and all lawful business allowed under the laws of the State of Florida or the United States of America. This professional association is for the purpose of providing medical services and practice.

ARTICLE IV: The professional association is authorized to issue 100 shares of common stock, with a par value of \$1.00 each.
