The Purpose for which the corporation is organized is the transaction of any or all of lawful business for which corporation may be incorporated under the Florida Corporation Act.



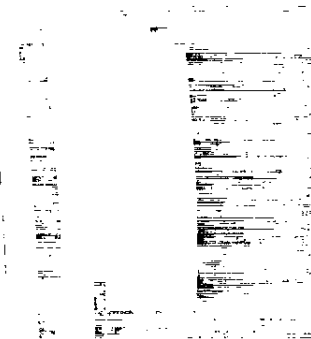

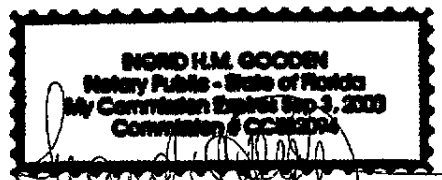
