
ARTICLE X - GENERAL





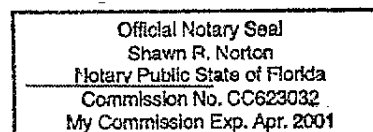
