The undersigned, acting as Sole Incorporator of a Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such Corporation:

**ARTICLE I**

The name of the Corporation is: **JOHN F. MAYO, P.A.**

**ARTICLE II**

This professional association is organized primarily to conduct the business of a Physician's Assistant. The Corporation may engage in any activity of business permitted under the Laws of the United States and of the State of Florida.

**ARTICLE III**

The Corporation's principal office and mailing address is 5720 Piper Glen Blvd, Jacksonville, FL 32222, and the name of the initial Registered Agent is John F. Mayo, whose address is 5720 Piper Glen Blvd, Jacksonville, FL 32222.

**ARTICLE IV**

The total number of shares of which the Corporation shall have the authority to issue is 1,000 shares of Capital Stock, and the par value of each share shall be \$1.00.

**ARTICLE V**




