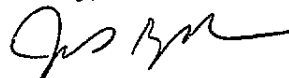

Pursuant to the provisions of Section 607.1403, Florida Statutes (1999), PALM ACCESS, INC., a Florida corporation, adopts the following Articles of Dissolution for the purpose of dissolving the Corporation:

1. The name of the Corporation is PALM ACCESS, Inc. The Corporation was incorporated under the laws of the State of Florida on October 28, 1998; and Articles of Amendment were filed on May 22, 2000.
2. The Dissolution of the Corporation was authorized on July 28, 2000.
3. The Dissolution was approved by the Shareholders of the Corporation. The number of votes cast for dissolution was sufficient for approval. The Corporation has only one class of voting stock.
4. No property or assets remained to be distributed among the Shareholders of the Corporation after the payment of all debts, obligations, and liabilities of the Corporation.
