ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF EVERCOM, INC.

Pursuant to the provisions of Section 607.1006 of the Florids Business Corporation Act (the "Act"), the undersigned President of Evercom, Inc., a Florida corporation (the "Corporation"), hereby executes and submits for filing with the Department of State, State of Florida these Articles of Amendment to its Articles of Incorporation to read as follows:

ARTICLE V of the Comoration's Articles of Incomoration is hereby amended by I. deleting the text of ARTICLE V in its entirety and substituting in its place the following:

> "ARTICLE V. AUTHORIZED SHARES. The maximum admiter of shares that the Corporation is authorized to have outstanding at any one time shall be one million (1,000,000) shares of common stock having a par value of \$0.01 per share. The common stock shall be divided into two (2) series: Series A common stock, of which there shall be one hundred thousand (100,000) shares authorized, and Series B common stock, of which there shall be nine hundred thousand (900,000) shares authorized. The Series A common stock shall have voting rights and the Series B common stock shall have no voting rights. Other than with respect to voting rights, the rights of the Series A common stock and the Series B common stock shall be identical. Upon the filing of the Articles of Amendment pursuant to which this ARTICLE V shall have been adopted, each share of common stock held by the sharpholders of record on the date these Articles of Amendment are filed shall he automatically converted into one (1) share of Series A common stock.*

- Except as hereby amended, the Articles of Incorporation of the Corporation shall 2. remain the same.
- 3. Pursuant to Section 607.1003(6) of the Act, this Amendment to the Articles of Incorporation was approved by the directors and shareholders of the Corporation by unanimous written consent effective November 12, 2001. Therefore, the number of votes cast for the amendment was sufficient for approval.
