The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

## ARTICLE I. Name and Address

The name of the corporation is **B-Square Design**, Inc. The principal office is 3202 Pine Shadow Drive, Land O' Lakes, FL 34639, and the mailing address for the corporation is 3202 Pine Shadow Drive, Lake O' Lakes, FL 34639.


