CORPORATE NAME AND ADDRESS

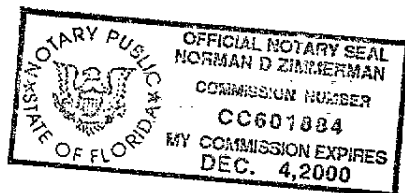
