At each election every Shareholder will be entitled to one vote for each share of stock that he/she owns. Election outcomes will be determined by a majority of the votes cast.



The By-Laws of this Corporation may be adopted, altered, amended or replaced by the Shareholders.

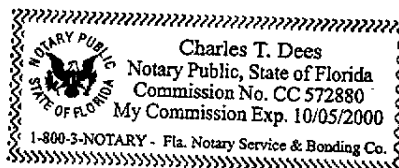
