The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is RIVER CITY INLAND GUIDES, INC.

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The general purposes for which the corporation is organized are:

- 1. To engage in the business of being a fishing guide for inland waterways of North Florida and, to transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act.
