OF

ARTICLE I. NAME

The name of this corporation shall be THE PURPLE ZEBRA, INC.

ARTICLE II. PRINCIPAL OFFICE

ARTICLE III. COMMENCEMENT & DURATION

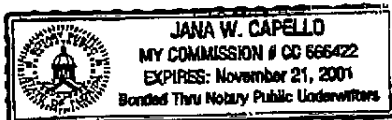
