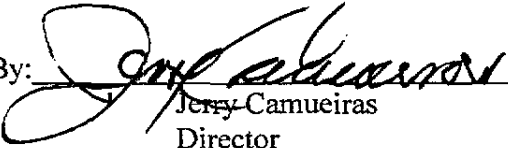
THIRD: The date of each amendment's adoption: **May 16, 2003.**
