WE, the undersigned, do hereby incorporate ourselves for the purpose of becoming a corporation for profit under Florida law.

ARTICLE I

The name of the corporation is: E. S. B. OF SARASOTA COUNTY, INC..

ARTICLE II

This corporation may own and operate hair styling salons and provide related services. The corporation may also conduct other related enterprises not prohibited by law.

ARTICLE III

The aggregate number of shares which this corporation is authorized to issue is One Hundred Thousand (100,000), all of which shall be common shares with a par value of One Dollar (\$1.00).

ARTICLE IV

This corporation shall have perpetual existence.

ARTICLE V

Each shareholder of any class of stock of this corporation shall be entitled to full preemptive rights to purchase any unissued or treasury shares of the corporation. Each shareholder shall also have full preemptive rights to purchase any shares held or owned by other shareholders of the corporation.

2.

Each shareholder of any class of stock of this corporation is also entitled to full preemptive rights to purchase any corporate securities carrying rights of subscription to, and/or acquisition of, any unissued or treasury shares.

ARTICLE VI

ARTICLE VII

The business office of the corporation is: 2069 South Tamiami Trail, Venice, Florida 34293.

ARTICLE VIII

The corporation's legal existence shall begin on that first day that it is legally qualified to transact business in Florida.

ARTICLE IX

The corporation may indemnify any officer, agent, or other corporate representative, when reasonable, to the fullest extent permitted by law.

ARTICLE X

The business of the corporation shall be managed by the shareholders.
