In compliance with the requirements of F.S. Chapter 607, the undersigned, being natural persons, do hereby act as an incorporators in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

**ARTICLE I
NAME**

The name of the corporation ("Corporation") is **HELTON & HELTON, INC.**

**ARTICLE II
PRINCIPAL OFFICE**

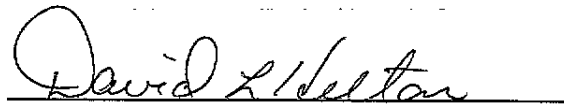

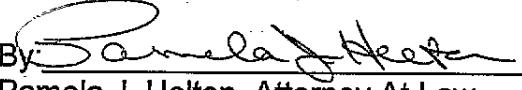
