

ARTICLE ONE

The name of the corporation is A-1 STUCCO AND STONE, INC. The principal office of the corporation is 29259 US Hwy 19 N., Clearwater, Florida 33761.

ARTICLE TWO

The period of duration is perpetual.

The Board of Directors is empowered to make, alter or repeal the bylaws of the corporation without restriction of their powers conferred by statute.



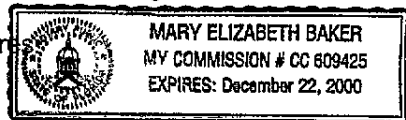


