ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is J.Q. McFarlan's, Inc.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: Suite 1820 1720 Harrison Street Hollywood, Florida 33020

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
