ARTICLES OF INCORPORATION

OF

38 Oct 71 CO KALYNN B. PRESSLY, A.R.N.P., P.A

The undersigned, natural person, competent, licensed and certified as an advanced registered nurse practitioner in the State of Florida, acting hereby as incorporator, for the purpose of forming a professional service corporation for profit under the provisions of Chapter 621 of the Florida Statutes (Professional Service Corporation and Limited Liability Company Act), does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be KALYNN B. PRESSLY, A.R.N.P., P.A.

ARTICLE II - PURPOSES

The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:

- 1. To engage in every aspect of nursing as are engaged in by advanced registered nurse practitioners.
- 2. To engage and render the professional services involved only through its officers, agents, and employees who shall be advanced registered nurse practitioners in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services corporation.
- To invest its funds in real estate, mortgages, stocks, 3. bonds and any other type of investment permitted by law.

- 4. To engage in no other business other than the rendition of the professional services specified herein.
- 5. To do everything necessary and proper in accomplishing the purposes herein set forth and do anything incidental thereto which is not forbidden under the laws of the State of Florida.

ARTICLE III - CAPITAL STOCK

- 1. The maximum number of shares of stock that the corporation is authorized to have outstanding at any one time shall be One Thousand (1,000) Shares of Common Stock at One and No/100 Dollars (\$1.00) per share par value.
- The consideration to be paid for each share shall be payable in lawful money or property, labor, or services.
- 3. Shares of the corporation stock and the certificates shall be issued only to advanced registered nurse practitioners in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as this corporation.

ARTICLE IV - DURATION

The corporation shall have perpetual existence.

ARTICLE V - PRINCIPAL OFFICE, REGISTERED OFFICE

AND REGISTERED AGENT

ARTICLE VIII - INFORMAL SHAREHOLDER ACTION

Any action of the shareholders may be taken without a meeting if consent, in writing, setting forth the action so taken shall be signed by all the shareholders entitled to vote upon such action at a meeting and filed with the secretary of the corporation as part of the corporate records.

ARTICLE IX - SEVERANCE AND TERMINATION OF EMPLOYMENT

If any officer, director, stockholder, agent or employee of
