ARTICLES OF INCORPORATION

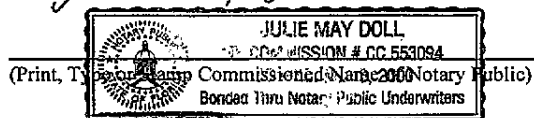

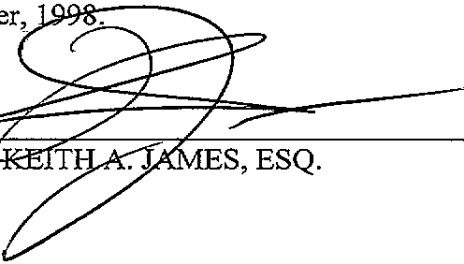
