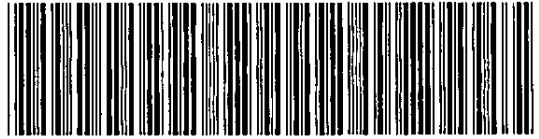

Pursuant to the authority of §607.1003 and §607.1006 of the Florida Business Corporation Act, the undersigned corporation, **NATURE'S CHOICE PRODUCE, INC.** (the "Corporation"), hereby adopts and files the following Articles of Amendment to its currently existing Articles of Incorporation:

- (1) ARTICLE FIRST: The name of the Corporation is presently "NATURE'S CHOICE PRODUCE, INC."
- (2) ARTICLE SECOND: Article I of the Articles of Incorporation of the Corporation is hereby deleted in its entirety, and is hereby replaced and superseded by the following replacement Article I:
