## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF WATERFORD POINTE APARTMENTS, INC.

The Articles of Incorporation of the Corporation are amended by deleting in its entirety and inserting the following Article III in its place and stead:
