ARTICLE I

NAME

The name of this Corporation is BAY QUATTRO, INC.

ARTICLE II

PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation is: 200 South Biscayne Boulevard, Suite 4815, Miami, Florida 33131.

ARTICLE III

NATURE OF BUSINESS

This Corporation is being formed for the following purposes:
