## ARTICLES OF INCORPORATION

### ARTICLE I

THE NAME OF THIS CORPORATION SHALL BE EVANS TRUCKING, INC.

### ARTICLE II

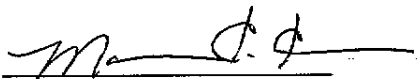
