ARTICLES OF INCORPORATION

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is ECONO-CLEAN OF FLORIDA, INC. and its principal place of business shall be located at 1212 Fanhurst Drive, Tallahassee, FL 32312.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE VII - DIRECTORS AND OFFICERS

The Directors of this corporation shall be elected by the shareholders at its initial meeting. Those directors shall serve until their successors shall be elected/appointed at the annual meeting of the stockholders and thereafter this corporation shall have no less than one (1) director con-

stituting the initial Board of Directors. The number of Directors may be either increased or decreased from time to time by the Bylaws.

Once the directors have been elected or appointed by the shareholders, the Directors shall elect the officers of the corporation.
