OF

ARTICLE I

THE name of the Corporation is: JR'S PRESSURE CLEANING
OF ORLANDO, INC.

ARTICLE II

The initial registered office in the State of Florida is located at 4241 Cloverleaf Place, in the City of Casselberry, County of Seminole. The registered agent in charge thereof is John R. Gann at 4241 Cloverleaf Place, Casselberry, Florida 32707. The principal address is the same as the registered office.

ARTICLE III

The nature of the business and the objects and purposes to be transacted, promoted and carried on are to do any or all things herein mentioned as fully and to the same extent as natural persons might or could do, and to any part of the world, viz:

"The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized and incorporated under Chapter 607. Florida State Statutes.

ARTICLE IV

The Corporation shall be authorized and empowered to issue Twenty Thousand Five Hundred (20,000) shares of capitol stock, consisting of one (1) class only and having no par value.

ARTICLE VI

The Corporation shall have perpetual existence, the date and time of the Corporate commencement shall be the date and time of filing of these Articles of Incorporation by the Secretary of State, Division of Corporations, Tallahassee, Florida

ARTICLE VIII

The director's shall have power to make and to alter or amend the bylaws', to fix the amount to be reserved as working capitol; and to authorize and cause to be executed mortgages and liens without limit as to the amount upon the property and franchise of the corporation.

With the consent in writing, and pursuant to a vote of the holders of a majority of the capitol stock issued and outstanding, the directors shall have the authority to dispose in any manner of the whole property of this corporation.

The bylaws shall determine whether and to what extent the accounts and books of the corporation or any of them, shall be open to the inspections of the shareholders; and no shareholder shall have any right of inspecting any account or book or document of this corporation, except as conferred by the law or the bylaws, or by resolution of the shareholders.

The shareholders and directors shall have power to hold there meetings and keep the books, documents and papers of the corporation within or without the state of Florida, as such places may from time to time be designated by the bylaws or by resolution of the shareholders or directors, except as otherwise required by laws of the State of Florida.

ARTICLE IX

The Directors of the Corporation shall not be liable to either the Corporation or its shareholders for monetary damages for a breech of fiduciary duties unless the breach involves: (1) a director's duty of loyalty to the Corporation or it's shareholders; (2) acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of the law; (3) liability for unlawful payments of dividends or unlawful stock purchases or redemption by the Corporation' or (4) a transaction from which the director derived an improper personal benefit.

I, the undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, do make file and record these Articles of Incorporation and do certify that the facts herein are true and correct to the best of my ability; and I have accordingly hereunto set my hand in seal.
