

ARTICLES OF AMENDMENT to the ARTICLES OF INCORPORATION of MORGANELLI & ASSOCIATES, INC.



Pursuant to the provisions of Chapter 607 of the Florida Statues, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

 $\underline{\textit{FIRST}}$: The name of the Corporation is MORGANELLI & ASSOCIATES, INC.

SECOND: The following amendment to the Articles of Incorporation was unanimously adopted by the shareholders of the corporation at a special meeting called for that purpose on November 3, 2003, in the manner prescribed by the applicable provisions of Chapter 607 of the Florida Statutes:

I. ARTICLE IV, CAPITAL STOCK, of the Articles of Incorporation is amended to provide as follows:

The aggregate number of shares of stock which the corporation has the authority to issue is TEN THOUSAND (10,000) shares, all of which shall be common shares with a par value of ONE DOLLAR (\$1.00) each. Common stock of the corporation shall be issued as "Small Business Corporation" stock, in accordance with a plan or plans under the provisions of Section 1244 of the Internal Revenue Code of 1986, as amended.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was one hundred (100); and the number of shares entitled to vote thereon was one hundred (100).

FOURTH: The number of shares voted for the amendment was one hundred (100).
