ARTICLE I

THE NAME OF THIS CORPORATION SHALL BE EXTERNAL OFFICE SYSTEMS

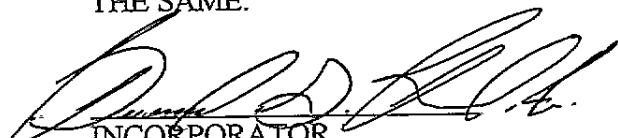

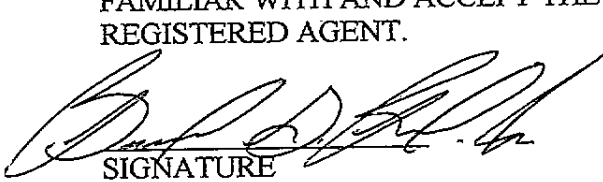

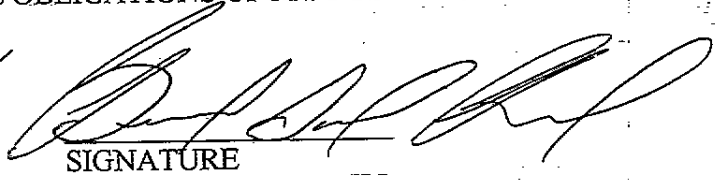
